#### **Duplication Estimates: n/a**

#### Variations:

Quotes for 5, 10 & 25 videos include combining multiple videos into single days of shooting. Individual videos shot on separate days are each considered Quote A.

Cost saving methods and additional services are available upon request.

Half-day of shooting is for up to 5 hours including travel from Toms River, NJ. Full-day of shooting is for up to 10 hours including travel from Toms River, NJ. Overtime charges start at \$75 per hour.

### **Payment Terms**

Quote guaranteed for 30 days from date above – deposit must be received to hold quote.

E Video Productions reserves the right to revise quote 12 months from acceptance of contract if project is not completed due to client delays.



50% deposit due prior to any work. Final payment due upon completion of project. Should there be any delays in the project, i.e. scheduling shoot days, providing graphics, additional editing, etc., client will be invoiced on a monthly basis. 5% finance charges will occur on all late payments. Interest-free monthly payments are available upon request.

Any additional work not mentioned in this estimate may be added to the payment terms listed above. An additional quote can be provided upon request. No projects will be sent for duplication when there is ANY outstanding balance, past due or current. No additional work will be completed when the client is more than 30 days past due on any invoices.

#### **Timeline Information:**

An estimated timeline can be provided upon receipt of signed contract, deposit & all supporting materials, including scheduled shoot days. No promises are made prior to receipt of all materials. Any delays from the client in providing materials or shooting dates may cause a delay in project completion. **First proofs are typically available within 2-4 weeks of receipt of all materials from the client**.

RUSH ORDERS are available. If you have a specific deadline less than 4 weeks from signing this contract, a rush fee of 20% will be added. It is the responsibility of the client to ensure E Video has everything necessary to meet deadline. Failure of client to provide E Video with necessary materials within 48 hours of signing contract may result in a delay.
